## Purpose and Description

Vista Real Charter High School is a Dashboard Alternative School Status (DASS) independent study, personalized learning program, for opportunity youth who are in need of credit recovery. The school has been identified for Comprehensive Support and Improvement (CSI) under the federal Every Student Succeeds Act (ESSA), because the single year cohort graduation rate was 67.8% for a two-year average (2018 & 2019), which is below the federal threshold of 68%.

Briefly describe the school's plan for effectively meeting the ESSA requirements in alignment with the Local Control and Accountability Plan and other federal, state, and local programs.

Through a collaborative process involving parents, students and staff, the school developed improvement strategies after doing a school-level needs assessment, determined evidence-based interventions, and examined the program for any resource inequities. The prior LCAP goal that aligns with graduation rate would be Goal #2: Increase Credit Completion Towards Graduation. We used the Professional Learning Community (PLC) model to look at data in a collaborative way that focused on outcomes. We drew from research-based strategies for improving graduation rates, sourced from the Department of Education, What Works Clearinghouse, and the Center for Equity and Excellence in Education.

## Stakeholder Involvement

How, when, and with whom did the school consult as part of the planning process for this SPSA/Annual Review and Update?

### Involvement Process for the SPSA and Annual Review and Update

Teachers, students and parents were involved in the planning process this September and October of 2020. Vista Real's school board was also able to provide input into the CSI plan at their October 19<sup>th</sup> meeting.

Meetings were held remotely due to COVID-19 requirements. Graduation rate and methods to improve Vista Real's graduation rate were put forth to stakeholders at staff PLC meetings, Parent Advisory Committee (PAC) meetings, and English Learner Advisory Committee (ELAC) meetings. Conversations between school staff (including counselors, social workers, and student retention support staff) and students and stakeholders are held on a continual basis. Senior events and information nights are held throughout the year to seek input directly from students and parents of students who are close to graduating. Additionally, we gather input from regular parent and student surveys as well as student graduate surveys and exit surveys.

Data gathered from stakeholder input indicate the following:

- \* Parents find senior parent meetings and events to be valuable and would like to continue having them on a regular basis multiple times annually.
- \* Parents find the one-on-one support from teachers and counselors important and beneficial and would like more opportunities for weekly for one-on-one counselor support.
- \* Parents like that their students are receiving college and career support, including support with financial aid and resume building.
- \* Parents appreciate community resources offered to their students.
- \* Parents appreciate tutoring and virtual tutoring support.
- \* Students enjoy the senior events offered and would like more frequent "large-scale" events like "grad night" at Disneyland or Magic Mountain.
- \* Students find value in goal setting and personalized learning plans.
- \* Graduate and Exit Surveys indicate graduates felt supported by staff and appreciated the flexible, one-on-one, personalized model. The surveys also indicate that graduates felt like they could utilize more support in computer skills, organizational skills, and career planning.
- \* Staff appreciate the tracking and support of seniors by the counselors and social workers.
- \* Staff appreciate the collaborative team approach to support seniors.
- \* Staff would like to see a formalized process to support seniors after graduation.

The Annual Review and Update are expected to be held in March/April of 2021. The progress made on the plan will be shared with stakeholders. Additionally, stakeholders will all have the opportunity to provide consultation into the Local Control and Accountability Plan.

## Resource Inequities

Vista Real is a charter school, so as a single school LEA, we are not required to do a resource review. The identification of the school for CSI status under ESSA was not attributed to resource inequities but in fact was attributed to the new way in which DASS schools' graduation rates would be calculated under the state and federal accountability systems. Analysis of data around state indicators, including graduation rates and policies, such as student placement, led to the actions described in this plan, which were implemented prior to CSI identification and have already resulted in positive increases in the graduation rate. The school will monitor and evaluate the effectiveness of their improvement plan throughout the school year. Furthermore, because Vista Real does not accept federal funds and did not accept any CSI funding all the actions taken will be paid out of LCFF funds.

All students who are able to graduate on time will be identified, monitored and supported throughout their time at the school. We will also monitor special education students, low income, homeless, foster youth, and English Learners.

Vista Real accurately identifies seniors early upon enrollment or upon their grade level change, and teams monitor and support them throughout the school year. The teams involve teachers, student retention support staff, tutors, counselors, social workers and administrators who carefully monitor the progress of students towards graduation. The team ensures every senior's Personalized Learning Plan is updated, tracks them to ensure they are on pace to graduate and offers interventions as needed. The team works one-on-one with each senior student to develop post-graduation plans, personalized goals, and provide them with resources to help them reach those goals. The team also offers small group support via workshops, senior recognition events, senior activities and parent events.

- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

#### Comprehensive Support and Improvement

The LEA shall, in partnership with stakeholders (including principals and other school leaders, teachers, and parents), locally develop and implement the CSI plan for the school to improve student outcomes, and specifically address the metrics that led to eligibility for CSI (Stakeholder Involvement).

The CSI plan shall:

1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable);
2. Include evidence-based interventions (Strategies/Activities, Annual Review and Update, as applicable) (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" at <https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseseinvestment.pdf>);
3. Be based on a school-level needs assessment (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
4. Identify resource inequities, which may include a review of LEA- and school-level budgeting, to be addressed through implementation of the CSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities; and Annual Review and Update, as applicable).

#### Targeted Support and Improvement

In partnership with stakeholders (including principals and other school leaders, teachers, and parents) the school shall develop and implement a school-level TSI plan to improve student outcomes for each subgroup of students that was the subject of identification (Stakeholder Involvement).

The TSI plan shall:

1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
2. Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" <https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseseinvestment.pdf>.)

## **Additional Targeted Support and Improvement**

A school identified for ATSI shall:

1. Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

## **Single School Districts and Charter Schools Identified for School Improvement**

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
