The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English Learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Vista Real Charter High School engaged with parents, community partners, behavioral health partners, and internal staff members to develop the Expanded Learning Opportunity (ELO) grant plan. General information and input was collected through staff and community surveys, interviews with educators, parents, community members and students. Additional information and feedback was collected through the Vista Real Charter High School Parent Advisory Committee (PAC) and the English Learner Advisory Committee (ELAC), as well as utilizing the Learn4Life Connect and Parent Square platforms to gain parent and community input. An additional component completed by Vista Real was utilizing counselors to gain feedback from foster, low-income, and at-risk students' parents and/or guardians, utilizing Student Retention Support (SRS) staff to engage disengaged students' parents and/or guardians, and utilizing Special Education (SPED) Specialists and SPED teachers and paraprofessionals to engage parents and guardians of SPED students.

Feedback from stakeholders indicated that 72% felt as though the number one need is for students to catch up on credits, followed by 52% of respondents recognizing the need for students to receive additional support in math skills. 44% responded with seeing a need for support in study skills and 40% see a need for additional mental health support for students.

Additionally, 46% of respondents expressed extended on-site appointment times is essential and 36% feel that on-site access to a quiet place to work for extended periods of time would be beneficial to close learning gaps created by the COVID-19 pandemic. 36% of respondents would also like to see an option for continued distance learning.

A description of how students will be identified, and the needs of students will be assessed.

Vista Real Charter High School will provide the learning recovery program to students who are included in one or more of the identified groups, (1) low-income, (2) English Learners, (3) foster youth, (4) homeless students, (5) students with disabilities, (6) students at risk of abuse, neglect, and/or exploitation, (7) disengaged students, (8) students below grade level, and (9) other students identified by certificated staff. Vista Real plans to identify students in need of academic, social-emotional, and other integrated student supports, on a regular and ongoing basis, through diagnostic and formative assessments. Identification efforts will be comprehensive and through a multitude of avenues, including, but not limited to, needs assessment surveys for students, parent and teacher interviews, and teacher telephone calls to parents and/or guardians. Vista Real will utilize student data to identify students that will include NWEA data, Illuminate data, credit and course completion data, attendance rates, graduation rates of student subgroups, standardized test results, reclassification rates and ELPAC data. An additional identification component of students will include Student Retention Support (SRS) staff data on struggling, at-risk, and disengaged youth.

The key identification component will include the student needs assessment to initiate and assess students' needs. Vista Real will assess and address the needs of students and their families through teacher, intervention staff, counselor staff, SPED teachers and staff, tutors, and paraprofessional meetings and input to best serve each individual student. This input will provide open dialogue on students needs and challenges to identify supports and opportunities for each student.

Vista Real Charter High School has comprehensive plans for informing the parents and guardians of students identified as needing supplemental instruction and support of the availability of the outlined opportunities. This will include general information and communication strategies, that include telephone calls, mailers, flyers, emails, social media information posts, and teacher, tutor and paraprofessional phone calls and communication efforts. Additional information and education of the opportunities for supplemental instruction and support will include utilizing the Learn4Life Connect and Parent Square communication platforms, information provided

at PAC/ELAC meetings, counselor meetings, Attendance Intervention Meetings (AIM) and IEP meetings. Vista Real aims to inform parents and guardians of the opportunities for supplemental instruction and support through additional strategies that include Parent-Teacher conferences with one-on-one and group discussions, and Open House information sessions.

In addition, Vista Real understands the emergent and vital need to provide information of the opportunities for supplemental instruction and support in parents and guardians' primary languages, to ensure effective communication and full understanding of opportunities. Vista Real will develop information materials in English and Spanish; this will include mailers, social media posts, and emails. In addition, Vista Real will utilize bilingual staff members to aide in communication efforts with monolingual students, parents and/or guardians to ensure effective communication of supportive services.

A description of the LEA's plan to provide supplemental instruction and support.

Vista Real Charter High School (the LEA), plans to implement a learning recovery program that provides (1) supplemental instruction, (2) support for social and emotional well-being, and (3) meals and snacks, as permitted to support the program. The outlined plan will provide a tiered framework that bases universal, targeted, and intensive supports on students' needs for academic, social emotional, and other integrated student supports.

Supplemental instruction, as outlined for the Expanded Learning Opportunity (ELO) grant plan, will include programs provided in addition to and complementary to Vista Real's regular instructional programs, including services and programs provided in accordance with an individualized education program (IEP). Vista Real will provide extended instructional learning time in addition to what is required, by increasing the days and times provided during the school year; this will include summer school, intersessional instructional programs, Saturday school, increased instruction time, and extended hours at school sites that increase the amount of instructional time and increase services provided to students based on individual learning needs. Vista Real aims to increase access to school counselors, increase EL/SPED/Bilingual paraprofessionals to increase supplemental instruction and support for students. Vista Real also plans to expand its Care-A-Van program. The Care-A-Van brings learning to our highest needs students' doorstep where a group of staff visit the students' homes, set up a folding table outside with a computer and hotspot, and work directly but safely with the students on their academics. The team can also provide social-emotional support and resources, counseling, and support with college and career planning.

Through the ELO grant funding, Vista Real aims to accelerate progress to close learning gaps through the implementation, expansion, and enhancement of learning supports that include tutoring services (one-on-one and group instruction) and learning recovery programs to accelerate student academic proficiency and English language proficiency. An additional component will include technical support and literacy assistance for students, parents, and staff. This aims to include increased efforts and offerings of Small Group Instruction (SGI) to our students.

One key component planned will include educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, which will include, but is not limited to, training in facilitating quality and engaging learning opportunities for all students. This will include staff trainings on cultural competency and proficiency, staff trainings on community building and community development, staff trainings addressing learning gaps for English Language Learners (ELL) and resiliency and trauma staff trainings. Within this professional development component, initiating learning programs and material development to accelerate ELL language proficiency and supportive services.

Vista Real Charter High School plans to utilize a portion of the Expanded Learning Opportunity funding to continue and aide students in continuation of distance learning or transitioning to in-person instruction; this will include equipment (i.e., laptops and internet hot spots) for students within distance learning parameters and supporting hybrid instructional options for students and staff. As in-person instruction increases, Vista Real will implement and increase COVID safety measures, as needed onsite.

Additional supportive programs and interventions will be provided to the target students, that supplement regular provided services provided by Vista Real, designed to meet students' needs for behavioral, social, emotional, and other integrated student supports. These services will enable students to engage and benefit from supplemental instruction. Integrated student supports to address additional barriers to learning, that will include access to school meal programs, transportation (i.e., bus passes for students), mental health services, referrals and linkages to supportive services and socio-emotional needs of students and families.

Vista Real will enhance sites as community learning hubs that provide students access to technology, high-speed internet, and additional academic supports. Vista Real will increase dual enrollment and Career Technical Education (CTE) classes and pathways for increased employment and certifications for our students.

Vista Real Charter High School primarily serves opportunity youth - students who are considered socioeconomically disadvantaged, at least 17 years old, severely credit deficient, pregnant or parenting, homeless, reading at a 6th grade level and functioning with math skills at a 5th grade level. In addition to the outlined targeted services, the ELO will provide additional supports for credit deficient students to complete graduation or grade promotion requirements, as well as increase and improve students' college eligibility.

Additional academic services for students will include diagnostic assessments, progress monitoring, and benchmark assessments for student learning. Vista Real plans increase training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students social-emotional health needs and academic needs.

Each of the outlined supportive programs and interventions will be provided through a program of engaging learning experiences in a positive school climate. Vista Real aims to provide comprehensive supplemental instruction, increased support for social and emotional well-being, and supportive services from a whole school lens. Providing increased instruction time, increased educational and supportive programs to students, professional development and learning opportunities for staff, and school enhancements for in person instruction to promote and increase engaging learning experiences in a positive school climate.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
