**II. Title I Annual Meeting Information**

**A. Allocation of funds**

- i. Vista Real has \$285,894 from Title I to spend on literacy/intervention staff, engaging educational partners, and providing services to homeless children.
- ii. Goals and actions are described in the LCAP which is posted to our website.

**B. Title 1 Program Evaluation**

- i. Explanation of Title I and how our school qualifies - 20-21 grad rate 67.6%, average NWEA reading score 1017L
- ii. 727 students were identified as eligible for Title I support, 1218 students completed the NWEA reading assessment, 118 parents/guardians completed the Annual Survey which shows that 87% of our parents “feel encouraged to participate.”
- iii. Only 36.6% of eligible students are actively enrolled were actively enrolled in a literacy course last year, only 76 of our students completed one full semester of school, ELAC attendance has been relatively low historically.

### C. LCAP review

i. Title I funds are allocated based on a needs assessment, proposed expenditures, review and input from PAC/ELAC and our educational partners, and approval by the school board.

ii. Parent/Guardian involvement activities for 22-23 school year include: open houses, PAC/ELAC meetings, progress conferences, parent workshops, and social media input.

### III. LCAP survey review from August ELAC

#### A. Time for additional feedback/completion of survey

i. We reviewed the survey results from our last ELAC. We asked parents to vote on which type of activities they would like to see more of this school year. The top choice was career field trips.

ii. We presented a second survey with more choices for which specific career fields trips parents and students would like. Those results will be shared and discussed during our upcoming PAC meetings.

A. Each learning center set up stations to teach parents about our literacy and ELD programs. Each station included a handout with information and the purpose and expectations of these programs.
