VI. Mrs. Dullam reviews the Budget Overview for Parents

A. Various funding sources: LCFF, state, local, federal - ~42 million total

a. one staff member expressed surprise at the amount
b. LCFF S&C is ~10 million - Mrs. Dullam explains that these funds are used to serve high needs student group such as foster, EL, low-income students
c. How the school will use the funding to serve these students is outlined in the LCAP
d. VR has preliminary Title 1 24-25 allocations which is showing an increase in funding this school year. We are looking to add staff to LCAP Action 1.7 - Title 1 Intervention programs and personnel to support students. More staff will allow us to support more students who struggle with academic performance and need additional intervention to address their learning gaps. Does everyone agree? - XI. Mr. Oates call for increased Ed. Partner participation.
- A. Those interested in participating in the PAC committee, please contact a teacher or an admin.
- XII. Nancy Mendoza Dual enrollment- opportunity to take college courses for credit while still enrolled in High school
- A. requirements for dual enrollment: must be turning in at least 2-4 credits per month, english and math core, attending regular appointments, admin approval
- B. Benefits Vista Real covers all costs, head start on college, experience college while under the safety net of VR, catch up or accelerate credits, classes available online or in-person
- C. Options include:
 - a. VCCCD (in-person or online)
 - i. We recommend and intro course, typically 3 credits.
 - ii. Must demonstrate responsibility and capability before taking higher credit courses
 - iii. Students can apply with a counselor who will support them through the entire process
 - b. West Hills College: business pathway, career exploration, college success,
 - i. 8 week classes, elective credits given in high school credits

A parent asked if it's for all students or just for seniors. Mrs. Mendoza says it's open to all students.

- D. Mrs. Mendoza reviews programs that award a certificate: emt, cyber security, legal secretary, auto ac service, etc.
 - a. These certificates allow a person to get a job right after certification

A parent asks if these are all online or in person. Mrs. Mendoza says there's typically a hands-on portion that requires in person attendance. It varies by course.

- E. Popular courses include film, television, paramedic, criminal justice, biotech, communication, game design.
